## **ANNA PAULINA MAYERHOFER/LUNA LIED ABOUT LENGTH OF SERVICE IN THE U.S. AIR FORCE**

### **MAYERHOFER/LUNA SEPERATED FROM AIRFORCE AT FOUR YEARS, ELEVEN MONTHS FOR A SIX YEAR CONTRACT**

The American Muckrakers PAC, Inc., today released a copy of Anna Paulina Luna's (aka Anna Paulina Mayerhofer) discharge form (DD-214) from the U.S. Airforce. Ms. Mayerhofer/Luna is a Republican primary candidate in Florida's 13th Congressional district.

In [previous comments on video with Central Florida News](#), and as outlined at [annalunatic.com](#), Mayerhofer/Luna claimed she was discharged from the U.S. Air Force after serving "five years and eight months." The exact term of service was four years and eleven months based upon the attached DD-214.

In addition, Mayerhofer/Luna has never served in the U.S. Air Force outside her base in the U.S., despite wearing military garb and holding a weapon of war in a fake photo shoots that portrays her as having been in a war zone or part of a deployed special operations unit.

David B. Wheeler, President of American Muckrakers PAC, Inc., said the following:

*"Why would anyone lie about their years in the service, pretend to have been on a deployed special operations unit, and lie about the reason for their requesting a discharge from the U.S. military unless they were trying to hide something?"*

*Mayerhofer/Luna needs to apologize to the members of the military in Florida that have honorably served and stop pretending she was in an active war zone. Adding years to your service, wearing military uniforms for show, and or lying about why you left the military disrespects the honor of every active duty and retired member of the military. She should be ashamed of herself.*

*Come clean Anna Paulina. Tell us the truth about your term of service, where you served, your reason for being discharged, and why you lied about all three. And stop taking photos in military uniforms and pretending you served in Iraq. You never left U.S. soil."*
